It is very important that students' interest in reading influences their learning outcomes, because a high interest in reading allows a person to understand the basics of science perfectly. The aim of this research is to what extent students increase their desire to read to understand articles at PGRI Banyuwangi University in order to get the expected results from the research. The method used is qualitative descriptive. Data was obtained from active students of the Guidance and Counseling study program at PGRI Banyuwangi University who attended lectures from the 2nd and 4th semesters of the 2022 and 2023 classes. Qualitative research collects data by observation and interviews. The PGRI Banyuwangi University Guidance and Counseling Study Program class of 2022 and 2023 still don't understand how to read articles well and also the requirements for completing lecture assignments. With this, we still don't understand what is being done and what the student understands. Reading articles is more searching on the *Google Scholar site* than on other websites. The results show that to avoid laziness in reading, students must first understand how they learn and change their behavior to create a personalized learning plan. I prefer to listen to course presentations during class. To read articles, don't read them often and also read social media on your cellphone more often. And so too As stated by a student from the 2022 PGRI Banyuwangi University Guidance and Counseling Study Program NTA, he said that I once tried to find out my learning pattern with one of the lecturers and it turned out that my learning pattern was visual. I mostly look at books in PDF format and online websites. However, I can still read physical books but am too lazy to borrow them from the library and also don't often read articles.

From the results obtained from SHF and NTA students, it can be seen that there are differences in learning patterns which show how they learn so they can feel comfortable in the learning process. However, they are less interested in reading especially the article. They are more interested in observing and reading content on social media or books, according to what they are currently reading.

Students at PGRI Banyuwangi University in the Guidance and Counseling Study Program in the classes of 2022 and 2023. Students still do not fully understand the content of the writing they read, which is an obstacle in completing course assignments. As stated by students from the PGRI Banyuwangi University Guidance and Counseling Study Program by SHF class of 2023, they said that they still don't understand how to read articles correctly, because there are several sentences that they still don't understand and there is a lot of writing in them. I read articles when a lecturer gives an order to look for articles according to the course being held at that time in class. And also as stated by students from the PGRI

Banyuwangi University Guidance and Counseling Study Program by NTA class of 2022, they said that I don't understand sentences that are too scientific, the rest I can still understand the reading from the articles I read. When I read articles I can read, but there is an assignment that requires me to read articles for the course assignment I am currently working on.

That SNF and NTA students have similarities in facing the same obstacles in understanding sentences in articles, both sentences that contain scientific terms and complex sentences. Article reading is only done when the lecturer provides articles that are appropriate to the course and looks for articles that are relevant to the course being worked on.

After reading, students can engage in a variety of independent or structured activities. Independent reading activities that many students do include writing and summarizing interesting quotes, noting vocabulary they don't understand, and discussing it with friends. Good words play an important role in promoting literalism by giving credibility to literary works. Lecturers regarding students who are "lazy to read" also depend on the availability of reading materials. This can be seen from the response of most students to the obstacles they face in completing reading assignments due to the unavailability of reading materials. The unavailability of reading materials makes students look for shortcuts in completing assignments by plagiarizing other people's work. The content of the reading will influence interest in reading (Pujiastuti et al., 2022).
